महोदया/महोदय,

I am hereby directed to inform the approval of Director General for extension of DG-ESIC Rate Contract No.142C,143C,144C,145C and 146C for 475 nos. of Drugs manufactured by Indian manufacturers as per the attached list, up to 31.10.2024 or till the finalization of New Rate Contract (whichever is earlier), subject to adherence to the following conditions: -

1. Supply order should be placed **ONLY on First Preference Holders.**
2. Willingness of the firm to supply on the same Terms & Conditions, as approved in DG ESIC Rate Contract(s) 142C, 143C, 144C, 145C & 146C.
3. No order should be placed in respect of drugs, which have been found to be 'Not of Standard Quality' on test analysis.
4. Amendments / orders (if any) already issued (copy enclosed interalia), time to time in respect of drugs of DGESIC RC's 142C, 143C, 144C, 145C & 146C have to be taken into consideration while placing the supply orders.

Extension for remaining 86 imported items approved in DG-ESIC Rate Contract No.142C-146C shall be subject to outcome of exemption orders (if any) issued from Department of Expenditure, Ministry of Finance, Govt. of India.

Procurement of remaining 86 drugs (copy enclosed) which were earlier approved in the Rate contracts 142C, 143C, 144C, 145C & 146C & for which exemption has not been accorded by GoI should be purchased as per purchase guidelines of Govt. of India giving due diligence to GoI initiative for Make in India items and per the instructions issued earlier by ESIC Hqrs.
